



Win Lean Limited Terms and Conditions

1. Win Lean Limited quotation is valid for 30 days, price is based up information at the time of quotation. Any additional information provided later by customers, may result in different price or lead-time.
2. The fabrication is based on 3D CAD drawing provided by customers, 2D drawings in PDF format will only be used for reference such as tolerances, threads, surface finish etc.. It is customers' responsibility to keep the consistency of detail between 2D and 3D drawings.
3. 100% upfront payment is required for all prototyping projects. For tooling projects, 50% pre-pay payment is required to kick off production. The other 50% balance will be due upon approval of tool samples or 30 days after shipment of tool samples.
4. Customers are aware of that the anodized process cannot achieve colour matching, the pantone number is for reference only.
5. These terms and conditions agreement represent the entire and integrated agreement between customers and Win Lean Limited and supersedes all prior negotiations, representations, agreements, either written or oral. These terms and conditions may be amended only by written instrument signed by both customers and Win Lean Limited.
6. In the event of design changes after acceptance of a purchase order, the customer agrees to cover the related additional cost that may incur because of the design changes. For example, if Win Lean Limited started or even completed a job, but then must rework or remake due to customers' design changes, the customer will need to cover the additional costs incurred.
7. The customer should not sign for any package that has external signs of damage without examining the contents first. Signing for a damaged package will invalidate any compensation claims.
8. Any non-conformance must be reported within 14 days of reception in order to make any claims against Win Lean Limited.
9. Win Lean Limited does not assume any liability for intent of use, regulation, license, or misuse of existing intellectual property including patent infringement, copyright or trademark infringement or other legal conditions that are the responsibility of the products originator or financially responsible party.
10. Customer retains sole legal responsibility for the design specifications and performance of the goods that are the subject of this transaction. Win Lean Limited will, to the best of its ability, provide a part representative of the Buyer supplied 3D CAD geometry that conforms to Buyer requested dimensions and Win Lean Limited Standard Terms and Conditions Effective March 2018, and to the tolerances specified on Buyer supplied 2D drawings. This work is done on a best effort basis and the parts shall not be deemed scrap if some tolerances are not met but the parts still function as intended.



11. Win Lean Limited shall assume no responsibility for the design of the goods that are the subject of this transaction. To the extent that Win Lean Limited personnel recommend design modifications or provide design analysis, simulation or advice, they do so to help meet the requirements of Win Lean Limited's own manufacturing process. These recommendations should be reviewed and verified (by the buyer) prior to beginning the process. All recommendations do not have guaranteed results but are used as general practice.

12. Win Lean Limited will keep customer drawings, designs and intellectual property confidential, if the information needs to be shared with a third party, that third party shall be subject to a None Disclosure Agreement (NDA), in accordance with the customers standard NDA.

13. Win Lean Limited shall not be liable for any failure to manufacture, deliver or provide, or for any delay in the manufacture, delivery or provision of, any goods to be provided hereunder if such failure or delay is caused by acts of God, fire, storm, earthquake, strikes, blackouts, labor disputes, riots, inability to obtain materials, equipment, labor or transportation, governmental restrictions, serious public health nuisance or any similar cause over which Win Lean Limited is unable to exercise control.
